I. <u>Treasurer's Report</u>

a. Report – Mike Holbrook

Mike communicated an ending Bank Balance of \$13,377.85 which includes the Future Fund amount of \$7000. Combining the bank account and the PayPal account as of November 31st, the total Club funds are \$14,138.24.

This leaves \$7,138.24 as an operating balance. This operating balance reflects over a \$3,000 decline from the ending operating balance in December 2018. There are 3 primary reasons for this decline.

- 1. Club voted to move \$3,000 to the Shelter Project.
- 2. Forgiving the Mowing Equip. Loan. By club Vote
- 3. Move approximately \$700 from the General Fund to cover the overshoot of the Shelter Project. By Club Vote
 Mike encouraged members to get their dues in by January (the due date) so we can better project a realistic
 budget. Mike also reminded everyone there is a \$10 late fee if you do not renew by February and a \$10 processing fee
 if you do not register online.
